2. **HRSA \$350 Million Initiative**

To CBO Award Recipients, Thank you for your outstanding efforts to build vaccine confidence and bolster COVID-19 vaccinations in underserved communities as part of HRSA's Community-based Workforce for COVID-19 Vaccine Outreach (CBO) program. We are writing to you today to encourage your collaboration with HRSA-funded health centers and health center look-alikes through the new Expanding COVID-19 Vaccination initiative. On Tuesday, November 22, 2022 HHS and [HRSA announced a new \\$350 million initiative](#) to increase COVID-19 vaccine uptake in their communities, with a specific focus on underserved populations. HRSA supported health centers will use these one-time funds to expand outreach and education, community engagement, and to increase COVID-19 vaccinations through mobile, drive-up, walk-up, or community-based vaccination events, in collaboration with community- and faith-based organizations. Funding for [Health Center Program](#) grant recipients and [look-alikes](#) is anticipated

to go out in early December and we will share the list of awardees with you at that time. We encourage you to expand existing collaborations with health centers in support of this initiative by locating and contacting potential health center partners using the [Find a Health Center](#) search tool. Coordinated outreach and vaccine events in communities across the country will support the [Biden Administration's efforts to get more Americans their updated COVID-19 vaccine](#) and further facilitate community engagement and strengthen partnerships that address health equity. Hubs will provide academic innovators with access to funding and product development experts to help them accelerate the translation of their scientific discoveries into products that improve health and save lives. Hubs contribute to local ecosystems by improving small business development, entrepreneurial culture, workforce diversity, and health disparities.

Applicants are encouraged to establish public-private partnerships and secure cost-matching to amplify the impact of the NIH award. While primary applicant organizations must have previously been a formal partner to a small business on a Small Business Technology Transfer (STTR) award, applicants are expected to partner with stakeholders across their region. Minority serving institutions and historically black colleges and universities are strongly encouraged to participate.

[The prior cohorts of eight REACH Hubs](#), which include 51 universities and technical colleges from 12 states, have trained over 1,900 scientists, launched nearly 50 startups, and supported projects that have secured more than \$200 million in follow-on funding to continue development toward patient access.
